



Now that the New Year is upon us the first thing that typically comes to mind is...you guessed it — Goal setting and New Years resolutions. Approximately 45% of Americans set new goals during the ring-in of the New Year. If you are in that 45%, you are either setting yourself up for success or failure. No one wants to attempt a positive change or set a goal only to lose focus in the first few weeks. It's estimated that 24% of people fail to achieve their goals every year.

It doesn't have to be that way. You can use the start of a new year to make significant changes that have a positive impact on your life. Brian Bosley from Torch Consulting gave me a great technique last year that helped me do just what I set out to – accomplish my goals! I'd like to share what I learned from him. It's a process called MCII. It stands for mental contrasting with implementation intentions and involves a four-step process.

- 1. Set 3 to 4 goals. A combination of both personal and professional goals. 1 to 2 should be something that are measurable and quantifiable.
- 2. Describe how it will feel once you reach each goal. Put as much emotion as possible to each answer. Describe the true benefit you and your loved ones will achieve by you reaching each goal.
